

CONTEST RULES [THIBAUT COURTOIS Shirt 2021]

ARTICLE 1: ORGANISATION

ARTICLE 2: ACCEPTANCE OF RULES

Valid participation in this contest automatically implies unconditional acceptance of the contest rules [below: 'RULES']. Consequently, every participant is deemed to have read, understood and accepted the content of these RULES unconditionally. The RULES can be consulted at any time on [<https://courtois8million.com/>].

ARTICLE 3: TERM

The contest will take place from 21/10/2021 at 10:00 CET to 24/10/2021 at 16:15 CET. Entries sent after this time will not be accepted.

ARTICLE 4: PARTICIPATION

In order to participate validly and stand a chance of winning Thibaut Courtois' match shirt from the Barcelona - Real Madrid match in the El Clásico on 24/10/2021, participants must:

- Enter the contest via Thibaut Courtois' own media channels
- Complete the contest form on <https://courtois8million.com/>
- Answer the three contest questions correctly.
 1. How many matchdays are there in total in a LaLiga season?*
 2. How many games did I play in total with Real Madrid?*
 3. Which shirt number is NOT one that I wore in my career?*
- The winner will be determined based on their answers to the contest questions and whether their answer to the tie-breaker question is closest to the correct answer to this tie-breaker question: How many people will have participated in this contest by 24/10/21, 16:15 CET?
- The prize can only be won if:
 - The participant only participated once
 - All three contest questions were answered correctly
 - The answer to the tie-breaker question is as close as possible to the correct answer.

- In case of a tie, the first participant who confirmed their participation will win the prize.

This contest takes place exclusively via <https://courtois8million.com/>.

The contest is open to any natural person, with the exception of THIBAUT COURTOIS' personnel and their relatives. The personnel of companies that are in any way, shape or form involved in the development and/or execution of this contest and their relatives are also excluded from this contest.

Participation in this contest implies the participant is over 18 years of age. If the participant is under 18 years of age, they must have the consent of their legal representative in order to participate in this contest validly.

ARTICLE 5: WINNER

The winner is the person:

- Who answered the three contest questions correctly;
- Whose answer to the tie-breaker question was the closest to the correct answer;
- Who was the first to give the answer closest to the tie-breaker question.

The winner will be announced on the official Instagram account of THIBAUT COURTOIS on 25/10. The winner will also be notified by email, where they will be asked for their (address) details so the prize can be sent by mail. If a winner does not meet the criteria, they will receive an email within two working days informing them that their participation was invalid and they have been disqualified. The prize will then be transferred to the next winner in line.

By accepting the prize, the winner of this contest authorise THIBAUT COURTOIS to use their name, photo and any other visual material on which they are depicted (e.g. at a prize-giving ceremony) for campaigns related to the contest. They will cooperate, if requested, in other activities related to the contest without any compensation other than the regular prize.

ARTICLE 6: PRIZE

The prize is an autographed shirt worn by THIBAUT COURTOIS during the El Clásico of LaLiga: Barcelona - Real Madrid on 24/10/2021.

The prizes are non-transferable to third parties, cannot be exchanged, cannot be paid out in cash, are neither expandable nor adjustable and are subject to the terms and conditions of the supplier. THIBAUT COURTOIS is not responsible for technical defects related to the prize. THIBAUT COURTOIS retains the right, where appropriate, to replace the prize with a similar and/or equivalent prize.

The prizes will be sent at the winners' risk to the address given by the participant-winner after participation. In the event of loss, the prize will not be replaced.

The prize will be sent to the winner within four weeks.

Any tax burden arising from this contest will be borne entirely by the winner.

ARTICLE 7: EXCLUSION & FRAUD

THIBAUT COURTOIS retains the right to exclude a participant from the contest and/or other current and future contests immediately or at a later date. In the event of fraud, THIBAUT COURTOIS retains the right to have the prize that the participant would have received by participating in the current contest reimbursed in the event of:

- Incomplete, incorrect or false personal or other data;
- Organised and/or collective (including automated) participation;
- Behaviour that may disrupt the smooth running of the contest for THIBAUT COURTOIS and/or for other participants;
- Any (attempted) fraud or unlawful action;
- Any breach of the current RULES;
- Any behaviour that is not in keeping with THIBAUT COURTOIS' business philosophy.

If fraud is suspected, it will always be reported to the competent authorities.

ARTICLE 8: LIABILITY

THIBAUT COURTOIS and any other person or company involved cannot be held liable if, due to force majeure and/or events beyond the control of THIBAUT COURTOIS and/or due to a depletion of prize reserves, certain terms of this contest and these RULES must be changed, or the contest must be interrupted, postponed, stopped or cancelled, or the award of the prize postponed or cancelled for any reason whatsoever.

Neither THIBAUT COURTOIS nor any other intervening person or company can be held liable for any damage of any kind arising from participation in the contest or the awarding of the prize. THIBAUT COURTOIS thus excludes, among other things, any liability for errors in (tele)communication, for misprints and misspellings or any defects in the prize.

THIBAUT COURTOIS retains the right to make changes to the RULES at any time. If any provision of these RULES is declared null and void, the remaining provisions of these RULES shall remain in full force and effect.

ARTICLE 9: COPYRIGHTS

By submitting the entry form, the participant transfers to THIBAUT COURTOIS all of their ownership rights to the photos (or the collages, drawings, slogans, etc.), including any copyright and/or personal rights they may have.

THIBAUT COURTOIS retains the right to use these photos (or collages, drawings, slogans, etc.) for the execution of his activity (e.g., publicity). THIBAUT COURTOIS can distribute or disclose the photos (or collages, drawings, slogans, etc.) to the public and modify them. The participant expressly gives their consent to destroy the works that were not selected.

The participant expressly renounces any remuneration related to sending their entry form and the accompanying photos (or collages, drawings, slogans, etc.).

ARTICLE 10: PROTECTION OF PERSONAL DATA

THIBAUT COURTOIS acts in accordance with the European General Data Protection Regulation (GDPR) of 2016/679 regarding the protection of personal data.

This data can be collected and processed depending on the consent given, in accordance with the ***Data Protection Declaration***.

Participants may withdraw their consent for the future at any given time by sending an email to performance.qbf@gmail.com. Withdrawal of consent does not affect the lawfulness of processing based on the consent before it was withdrawn.

ARTICLE 11: DISPUTES

In the event of force majeure, if unforeseen circumstances should arise or in the event of a dispute, THIBAUT COURTOIS will be able to take any decision necessary to ensure the smooth running of this contest. His decisions are sovereign and final.

The present RULES are subject to Belgian law and shall be interpreted and enforced in accordance with Belgian law. In the event of any dispute in connection with this contest, which cannot be resolved amicably, the courts of Brussels shall have sole jurisdiction.

ARTICLE 12: COMMUNICATION

Except in the cases provided for in the present RULES, this contest will not be the subject of written correspondence, nor will there be telephone or other communications, either during the contest or after its conclusion. [Consequently, no list of winners will be communicated.]
